- Whilst the terms and conditions which apply to your grant will continue in force, please be assured that **we will listen to your experiences as a charity and aim to respond to this situation compassionately**.
- **Our grants programmes continue to remain open**, please visit our [funding programmes](#) section should you wish to apply or call **0345 124 1351** for further information.
- We want to reassure you that **we will do whatever we can to support you in the coming weeks and months during these exceptional and difficult times**.

Here are the responses to the COVID-19 outbreak and how they relate to you:

- **For those wanting to submit a new proposal**  
Our Trustees decided at the Q1 2020 meeting that we would not accept new proposals for the Q2 2020 meeting in May. This decision was unrelated to the virus and relates to internal changes and improvements. If you would like to submit a proposal for consideration at our **Q3 2020 meeting in September 2020**, please go ahead and [get in touch with us](#). We will work alongside you as usual, keeping interactions virtual (phone/videoconference and email) for the time being, and will hopefully arrange for personal meetings in June/July.
- **For those currently receiving grants from us**
- **Flexibility**  
We understand that current and future restrictions will affect your organisations and the beneficiaries you serve. Please rest assured that instalments will be paid as usual even if projects cannot currently be delivered as planned, especially if funding is going towards staff cost. Please make sure to follow the [Scottish Government’s advice](#) as well as the [NHS's latest guidelines](#) on how to operate in your setting to keep beneficiaries and staff safe. If you feel that the situation requires you to spend funds differently – for instance divert funds from project to core funding – please get in touch with us so we can discuss this with you.
- **Reporting**  
We will also take into account COVID-19 when it comes to evaluation reports and don’t want to add additional pressure. If you feel that you might struggle to meet a reporting deadline or if you had to adjust your activities, please get in touch. We are here to chat about your concerns so we can find a solution together.
- **Emergency response**  
**Cattanach will work on plans to further support current grantees during the COVID-19 outbreak, financially and otherwise. Plans will be published on the website so please check back regularly. We are also working on a joint and coordinated response together with other grantmakers across the Scottish Grantmakers and the Scottish Funders Forum as well as through the SCVO.**
- **Your thoughts matter**  
We are here for you and want to help in any way we can. Please let us know if and when it is the right time for you to have a chat – you know your organisation and beneficiaries best and we are here to listen.
- **For anyone wanting to get in touch with us**  
We will do our bit to flatten the curve. Our staff will work from home until further notice and our [landline will not be monitored](#). Please get in touch via [email](#) in the first instance and we will arrange calls and video-conferences with you as soon as possible.

## Corra Foundation

The foundation wants to reassure people and organisations that they will do all they can to help on this challenging situation. If you will like to apply for funding with Corra foundation please go ahead. If you are currently funded by Corra Foundation, here are a few things to know:

- *Make sure grant payments are processed as normal.*  
we know how important this is, particularly where our grant contributes to someone's salary. Any Corra grants that contribute to someone's salary will continue to be paid, even if that person is unable to deliver their role due to the impact of Coronavirus.
- *Offer flexibility around timescales and how funding is used.*  
We recognise the current situation could impact in a range of ways. For example: some face-to-face delivery roles may have to be suspended for a period; charities' resources may need to be redirected; support might need to be delivered in different ways; and the timelines you planned may have to change. We're happy to have a conversation if you would like to use your funding differently or over a different time period than originally planned.
- *Allow for the impact of the current situation when reading charities' reports.*  
We understand that it might be difficult for you to meet the outcomes of your grant. If you feel a conversation about this would be helpful, please do get in touch. However, we will expect to see this reflected in many organisations' funding reports and given how busy many charities are please don't feel you have to take time out to discuss this with us outside of your regular reporting.

## The Robertson Trust

The trust recognises that the coronavirus outbreak presents an extraordinary challenge to the way our communities currently support one another. As many of their funded organisations will be affected in the weeks and months to come, the trust have contacted organisations they work with to make them aware of the following measures put on place to make the months ahead easier and assure them that:

1. The Trust will not ask organisations to return any unspent funds, for example, if a project or services can't be delivered or needs to be postponed.
2. Those in receipt of a restricted revenue award from the Trust, which now needs to be used in a different way as a result of the current crisis, can do so without having to let us know. We simply ask that they update us as part of future reporting.
3. Those with a pledged revenue or capital award from the Trust which has not yet been released will receive an extension to the standard 12-month period if a project is delayed.
4. The Trust understands the pressures placed on the third sector as a result of this crisis. We have written to organisations to let them know that they do not need to ask our permission or tell us about such changes now. However, we have requested that they keep us informed as part of their routine reporting.
5. We have also relaxed the reporting requirements for multi-year grants, simplifying the process and time required for reporting.

## Foundation Scotland

The foundation is open as usual- staff are currently working from home as IT systems enable them to work from home with no risk to data security and ensuring there is limited disruptions- all contacts including telephone numbers and email address will remain the same. Foundation Scotland will do what they can to support communities throughout these challenging times.

They will continue to welcome applications for funding but note that their offices are currently close and cannot receive mail. Please scan and email any supporting documents. If you don't have a scanner an option is to download a scanner app onto your smart phone – this uses the camera function to scan the document and convert it into a PDF for e-mail.

To support grantees and continue to deliver all community funds and published grant-making programmes, they are taking the following steps:

1. Relaxing deadlines for monitoring reports
2. Increasing mentoring and support for grantees and investees
3. Establishing payment holidays for social enterprises supported with loans
4. Increasing cash flow support loans to social enterprises
5. Planning to introduce rolling deadlines for some place-based Funds for those delivering any projects that address immediate community needs in light of the Coronavirus
6. Working with other funders to pool resources
7. Working with local community organisations and umbrella groups to gather information about local needs and how best to support these
8. Establishing a Community Resilience and Recovery Fund
9. Giving our staff paid time to work flexibly so that they can care for loved ones and also volunteer and support activity in their local community dealing with needs arising from the Coronavirus
10. Asking you how we can best support your community

- Financial flexibility – we know you may need to use your funding to help cover sickness, purchase equipment, or deliver services differently, and we will be reasonable if you need to move money between budget headings to ensure your work can continue; an
- Listening to you – we are here if you want to talk to us about the situation you’re facing, but we’ll wait for you to call us so that these conversations are at the right time for you.
